

There are other allegations in the declaration which need not be noticed further than to say that attorneys fees were claimed under the statute hereafter referred to. The policy was attached to and made a part of the declaration . The defendant filed its motion to strike those allegations of the declaration claiming attorneys fees upon the grounds: 1. There is no law authorizing such recovery. 2. There is no law which required defendant to pay attorneys fees before suit brought and prosecuted. 3. There is no law authorizing plaintiff to demand such fees before suit brought and prosecuted, consequently there can be no failure to pay on which to predicate a demand and refusal. This motion was overruled, and the ruling is assigned as error. The court at the trial instructed the jury to find for the plaintiff an additional sum as attorneys fees to be fixed at such reasonable amount as was shown by the...
